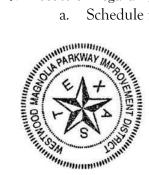
NOTICE OF MEETING WESTWOOD MAGNOLIA PARKWAY IMPROVEMENT DISTRICT MONTGOMERY COUNTY, TEXAS

The Board of Directors of Westwood Magnolia Parkway Improvement District (the "District") will hold its regular monthly meeting, on Friday, July 9, 2021, at 12:00 p.m., at Zanti Cucina Italiana, 10000 Research Forest Drive, Magnolia, Texas to discuss and, if appropriate, act upon the following:

- 1. Approval of prior minutes;

- 6. Sales tax report, including review of property owners/tax accounts inside District boundaries;

 - a. Acceptance of easement/site conveyance(s);

 - i. Research Forest Drive right-turn lane;
 - ii. Tamina Road right-turn lane(s);
 - c. Update regarding nearby traffic improvements and related projects;
 - d. Review and consider actions items related to Woodtrace Boulevard Extension Project;
- 9. Financial/Bookkeeping matters, payment of bills, review of investments, review and consider approval of reimbursements, amendment of budget;
- 10. Executive Team report, including:
 - a. Economic Development, FM1488 median landscape and Tamina Road improvements;
 - b. Signage matters;
- 11. Regional Detention Basin Maintenance Report;
- 12. Grant Project/funding updates;
- 13. Attorney's Report, including:
 - a. Authorize drafting of revised Records Retention Policy;
- 14. Executive session**;

- 16. Review of Financial Advisor updates and matters related to proposed Series 2021 Sales Tax Revenue Bonds (the "Bonds"), including:
 - a. Approve Preliminary Official Statement, plan of financing, schedule, and other matters in connection with the issuance, sale, delivery, and closing of the Bonds;
 - b. Engage Special Tax Counsel (if applicable);
 - c. Authorize Attorneys and Financial Advisor to take all other action necessary in connection with issuance of the Bonds.
- 17. Discussion regarding pending business and matters for possible placement on future agendas, including:
 - a. Schedule relating to future meetings.
